

Oregon Legislation: Considerations for Small Businesses in 2015

Mandatory Paid Sick Time, House and Senate Bills

Many of Oregon's legislative debates have the potential to profoundly impact businesses and business leaders on the Southern Oregon Coast, including members of the Bandon Chamber of Commerce.

Bandon chamber policy is to monitor issues and deliver information to our members on issues that most impact them. The chamber board limits collective political advocacy. The BCC board appended, in February, a letter of opposition to Senate Bill SB 454 and House Bill HB 2005 for submission to state representatives by the Oregon State Chamber of Commerce.

Senate Bill <u>SB454</u> and House Bill <u>HB 2005</u> introduced mandatory employer-provided paid sick leave, an issue that we feel could have a significant impact on the Bandon business community.

In brief, both bills mandate every Oregon employer provide 56 hours of paid sick time per year; employees would accrue one hour of paid sick time for every 30 hours worked.

The broad objective is to reduce the number of sick people at work. But, these bills do not exempt small business, or employers who cannot afford to provide more than a week's wages and benefits to each worker.

How the law may affect your business:

- Companies with few employees have fewer choices for replacements, requiring pay for both sick workers and their replacements
- Additional record keeping to track hours accrued and used
- Liability associated with unused benefits

How this law may affect your employees:

- Possibility of cutting hours and reducing payroll to pay for paid sick leave
- Reduced opportunities for part-time and teenage workers
- Eliminating other preferred benefits, or increased cost for current benefits

Oregon business associations discuss the state's minimum wage

Wage discussion among lawmakers and constituents includes consideration for boosting the state's minimum wage rate in the coming years, up to \$15 per hour.

Oregon's minimum wage is \$9.25 per hour in 2015. Some professional associations have expressed concerns about minimum wage increases beyond annual adjustments for inflation.

The Oregon Lodging and Restaurant Association has expressed opposition to "increases in the minimum wage that do not take into consideration the effects on entry-level or tipped employees."

The published Oregon State Chamber of Commerce 2015 Legislative Agenda includes

many topics of interest to Oregon business owners, including taxes, transportation, and energy. OSCC comment on minimum wage:

Already one of the highest minimum wage rates in the nation, Oregon's minimum wage increases each and every year based on the Portland CPI. Increasing the minimum wage to \$15 per hour will have the effect of immediate and significant job loss, especially among young and low-skilled workers.
