☑ READ UP ... Minimum wage legislation

Proposed Oregon minimum wage increase has prompted opposition from businesses and elected representatives across the state.

In a February letter to Oregon legislators, Coos County Commissioners expressed opposition to any minimum wage legislation in the 2016 session, noting, "We believe the proposals are fiscally irresponsible and would further increase the urban/rural divide, rather than uniting us as one Oregon. It would cause low paying, entry level jobs such as call centers to locate in depressed rural areas and manufacturing and industrial jobs to locate in the Portland metro region, further exacerbating poverty in our most challenged areas of the state."

The Coalition to Defend Oregon Jobs has published a report citing potential consequences of a dramatic increase in minimum wage. Topics include minimum wage impact on schools, local governments and small businesses. The coalition represents several Oregon business organizations, including the Oregon State Chamber of Commerce, Oregon Restaurant & Lodging Association, and Oregon Farm Bureau.

Gift certificates and promotional giveaways are great tools for business owners. Use them to promote products, entice new customers, or make shopping easier for your regulars. Here's a quick review of state laws designed to protect consumers.

Gift Cards

According to Oregon rules, a gift card is a prepaid certificate or voucher; gift card refers to "a prefunded record evidencing a promise that the issuer will provide goods or services to the owner of the record in the amount shown in the record."

If you sell a gift card, the card may not expire or decline in value over time. The card holder may not be charged additional service or maintenance fees to keep the card active. And, the card holder may redeem the card for cash or check when the face value of the card has declined to an amount less than \$5 and the card has been used for at least one purchase.

Gift cards may have an expiration date if offered for free, or less than full consideration, to a person or entity as a donation or as part of a promotional offer. Be sure to ask about the date of the charitable event for which you donate a gift card, since the recipient is entitled to a minimum of 30 days to redeem the card or certificate.

You may sell or donate a gift card that expires if:

 $\cdot~$ the card bears, in at least 10-point type, the words EXPIRES ON or EXPIRATION DATE followed by the date on which the card expires;

- the person sells the gift card at a cost below the face value of the card; and
- the gift card does not expire until at least 30 days after the date of sale.

Different rules may apply to prepaid phone cards, commercial mobile radio services, online sales, and gift cards usable with more than one seller of goods or services.



Gift Cards & Giveaways Did you know? Your customers may request cash back on their gift card if they've made a purchase and the remaining value on the card is less than \$5.00.

Giveaways

Rules for prizes, giveaways, sweepstakes and contests are different for non-profit organizations and for-profit businesses. For answers to questions about non-profit promotional activities, contact the Oregon Department of Justice Charitable Activities Section, 971-673-1880.

Legitimate prize promotions must clearly disclose the terms and conditions in plain English, according to the Oregon DOJ. Depending on the type of promotion, other details must be made known.

• Prize Promotions must disclose the retail price of the prize, the cost to participate including any applicable taxes and the exact amount of any shipping or handling charges.

- Sweepstakes must explain the odds of winning and the rules for entering without making a purchase.
- \cdot Contests must describe the total number of rounds in the contest, what entrants are responsible for, the identity of the judges and how they will determine a winner.
